Elgin SMP/Recycling and Waste Management

The **Recycling and Waste Management workgroup** has spent the last meetings fine tuning their goals and objectives, which include:

Goal #1 - Encourage increased recycling and waste reduction in residential properties.

Objective:: Within three - five years implement a pilot program for composting/organics.

Objective:: Host a yearly community recycling day that would be a central drop off center for numerous recyclables that cannot be put at the curb.

Objective:: Create a recycling booklet similar to Kane County's that instructs the what and where for certain materials. Or distribute Kane County's booklet.

Goal #2 - Implement increased recycling and waste reduction in businesses.

Objective:: Within the next two years, educate the local business on recycling.

Objective:: Within the next three years implement a pilot recycling program (and maybe incentive program) for the local businesses.

Objective:: Within five years pass a ordinance for the local businesses to recycle.

Goal #3 - Educate the public on the who, where, why's and what's on recycling.

Objective:: Have Waste Management host a yearly community education event on recycling.

Objective:: Have Waste Management yearly go into the elementary schools and educate on recycling.



Mock Election for South Elgin Students

On October 5, 2010, students at South Elgin High School will cast their ballots in a **mock election** conducted by The League of Women Voters of the Elgin Area in participation with Illinois Student Vote. The purpose of this program is two-fold: 1) to teach the mechanics of voting and 2) to teach students the duties of public officials, the issues of the campaign and how to make an intelligent, informed choice about the real candidates on the ballot.

The U.S. Election Assistance Commission (EAC) and the McCormick Foundation have awarded a grant to the League of Women Voters of Illinois to fund this project in which Leagues from nine counties are participating.

The **Mock Election Committee** includes Wendy Covich (Chair), Barbara Evans, Faye Blake, Loni Mecum and Laurel Bault.

“South Elgin High School is excited to be one of the only schools in Kane County to participate in this amazing opportunity,” said Walt Gola, AP U.S. Government & Politics teacher in U-46 for 10 years, four of which have been at South Elgin High School. “It will be a great chance for our students to see how elections are really carried out. Hopefully our students become life-long voters because of this opportunity.” Mr. Gola and Tracey Jakaitis are in charge of the Mock Election at South Elgin High School.

The Kane County Clerk’s office, Election Division, is cooperating in this effort by preparing a mock ballot containing U.S. Senate candidates, Illinois gubernatorial candidates, Congressional candidates, and an issue referendum. They’ll provide electronic voting devices to the high school; Junior and senior students will act as election judges. On Mock Election Day, we’ll have Volunteers to help students conduct the election. Roughly 1,200 students will participate during 8 class periods - about 100-200 students moving through the voting site each period.

“Having taught high school for many years, I know how important it is to be able to relate what is going on in the world to lessons in the classroom,” said Barbara Evans, a member of the **Mock Election Committee** and coordinator with SEHS. “Naturally Government and Politics and U.S. History teachers have included the up-coming elections in their courses of study, but to be able to have their students

vote on actual machines—Priceless, as MasterCard would say.”

Students will take part in at least 3 election-related activities before they vote, such as issue research, candidate/issue debates, analysis of political cartoons, exit polling, and some form of mock voter registration.

The McCormick Foundation's mission is to advance the ideals of a free, democratic society by investing in children, communities and country. It believes civic health is not only essential to building the real power of society, it is the Foundation.

The U.S. Election Assistance Commission was established by the Help America Vote Act of 2002 (HAVA). As an independent, bipartisan commission, EAC develops guidance to meet HAVA requirements, adopts voluntary voting system guidelines, and serves as a national clearinghouse of information on election administration.

Proposed Amendment (HJRCA31) to the Illinois Constitution

Recall of the Governor

At the November 2, 2010, General Election, voters will be asked to decide whether the Illinois Constitution should be amended to add a new Section 7 to Article III, Suffrage and Elections.

The **proposed amendment** would provide for a special election to recall a governor and for a special election to elect a successor governor.
