State of the State Luncheon Report

The League of Women Voters of Illinois, celebrating 90 years, held their annual State of the State Luncheon on June 2 at the Union League Club of Chicago. The Union League was established 125 years ago and it exudes elegance and history with an art collection one could spend hours viewing in total delight. The ambiance as well as the keynote speaker, Patrick Collins, made the luncheon most memorable.

Patrick Collins is the former assistant United States Attorney who prosecuted our state's former governor, George Ryan. Mr. Collins was also appointed by Governor Patrick Quinn to chair the Reform Illinois Commission to help remedy the "culture of corruption" running rampant in our state. He and his committee traveled the state, holding forums to listen to Illinois residents about their thoughts and experiences with Illinois government. From this fact-finding mission, he suggested reform efforts that could have a "game changing" effect on our state. Unfortunately, few of his suggestions were adopted by the Illinois legislature.

Although the League did not collect enough signatures, Attorney Collins praised the League's valiant effort in collecting signatures for Illinois Fair Map, which was one of his proposals to stop corruption. Had the citizens' initiative passed, it would have taken the power of redistricting away from the politicians and put it into the hands of an independent commission, giving the voter a more equitable choice in choosing candidates.

Mr. Collins called on fellow citizens of Illinois and especially civic-minded groups like the League to promote a concerted effort to change the culture of corruption. He said that we cannot blame only the politicians, but also ourselves, for allowing the political scandals and unethical behavior in our state. In his book, *Challenging The Culture of Corruption*, he says: "Ultimately, when corruption continues unabated for decades, it is far too easy for us to throw up our hands and opt out of the political process. When this happens, we collectively suffer a most severe consequence: loss of faith in democracy itself."

Just as the trial of former governor Rod Blagojevich begins, the timeliness of Collins' words were especially profound and add credibility to a former president of the Massachusetts League of Women Voters, Lotte Scharfman, who said, "Democracy is not a spectator sport."

Scharfman was a refugee of Nazi Germany.


