# Notes on the Budget Proposed for 2011 - 2012

Per our by-laws, this Voter includes the **budget for LWVEA for 2011 - 2012** (page 7), as approved by our board, to be voted on at our **Annual Meeting** on April 28.

As most of you will agree, budgets are, with any luck, educated estimates of how much money will be available and how much will be needed. Some revenue is relatively fixed (dues per member, for example) and some is totally variable. Contributions and specific fund-raising projects are examples of the latter. We earn about \$650 for each election from Kane County. This fiscal year we 'volunteered' during two; next FY there will be only one, so we can count on half the revenue.

In 2010 - 2011, individual contributions were much higher than in previous years, suggesting to the budget committee that we may be able to count on such support again. Another dues increase was discussed and rejected.

Here's the gist of the situation: For each individual member who pays \$60 in dues we must send a PMP (per member payment) to LWVIL of \$27 and to LWVUS of \$29.50. That leaves \$3.50 of each member's dues to support our entire operation and programming for the year. Before the 33% dues increase effective for the current year, we were collecting less in dues that we were paying out!

We have stopped the bleeding, but we still need more revenue to make it all work. So, special fund-raising has been proposed: A campaign involving the membership—each member brings in one ad for the newsletter, at least at the \$25 level. More discussion on this topic at the Annual Meeting. A second and bigger potential revenue source—co-sponsor a carnival to bring in at least \$1125. If this idea flies, you may hear more about it even before the Annual Meeting.

Both the ad campaign and the carnival would replace lots of bake-sale pies. Nobody wants a bake-sale anyway. And the alternative ideas are low-calorie and non-fattening!

The League of Women Voters of **Elgin's Mental Health Committee** will be presenting their findings on the work they accomplished throughout the year on nursing homes and persons with mental illnesses who reside there. Previously, the Elgin committee worked with other area Kane-county wide leagues to study the state of care, hospitalization, and housing targeting two groups: adults with serious mental illnesses and persons with developmental disabilities. After the study's completion and League consensus, the group chose to examine and take action on one of the study's outcomes concentrating on housing for persons with mental illness and developmental disabilities. The complete Profile of Community Services 2007 is located on the League's website. This past year, the **Elgin MH committee members** decided to continue investigating housing alternatives--specifically nursing homes.

We invite you to join us and listen to the committee members summarize the three nursing homes visited. There will also be some historical background given, the reason behind this activity, and the future activities the mental health committee is tentatively planning for the next program year.
